



Bridal Hair & Makeup Contract

Complimentary Consultation

We will discuss your hair and makeup needs and schedule both a practice run and wedding day services. Our contract and cancellation policies will be reviewed and a \$100 non-refundable deposit to save the date will be collected. Since spring and summer weekend dates are always in short supply, we recommend that you book your wedding services at least 4 months in advance.

Practice Run for the Bride

This should be scheduled 3 to 4 weeks prior to your wedding. Bring everything you'll wear on your big day, such as your veil, jewelry, and so on. Please view this as your wedding trial run.

- Bridal Hair Trial (starting price) \$90
- Bridal Makeup Trial (starting price) \$90

Wedding Day Hair & Makeup

We will recreate the look we achieved during your practice run. Please remember that everyone in your wedding party is welcome to join us for services on your wedding day.

- Bride Up Do (starting price) \$90
- Bridal Party Up Do (starting price) \$90

This is a base rate. Please note: If hair extensions or a more detailed style is wanted the price will change.

- Hair Extensions add \$10
- Bride Makeup \$90
- Bridal Party Makeup \$90

Please note that wedding party services are per person, per service. We do offer eyelash extensions. You can choose from either eyelash strips or individual eyelashes. Please let us know if you want these services done on bridal trial and/ or wedding day. We need to know in advance in order to have proper eyelashes in stock.

- Additional \$15 (with another service)
- \$25 (without other service)

Off-site Travel Fee

For those who need us to travel to their location, please schedule wedding services at least 4 months in advance. Travel fees are additional to our regular service costs.

- 25 miles round trip or less: \$25 flat fee
- Over 25 miles: \$1 per mile round trip

Important Information for Your Bridal Services

To help us serve you better and ensure that your wedding day runs smoothly, we ask that you and your wedding party please follow these simple guidelines.

- Please arrive with clean, dry hair to help the hold of your hairstyle. An additional fee may apply if you request a wash and blow dry/ straightening.
- Make sure your face is cleansed and moisturized prior to your arrival at our salon to ensure that the makeup holds all day long.
- During your trial run, please wear pants/ skirt and an ivory or white shirt that is as close as possible to the color of your wedding dress to ensure that your makeup is correctly matched.

- Please bring in your headpiece, veil, and any other hair accessories to try on.

- On the day of your wedding, you are invited to bring in any drinks or food that you feel will make your day more special. We do offer complimentary tea and coffee, but you may feel free to bring in a more personalized selection.

- Most importantly, please be on time for your wedding day appointment. Even starting 15 minutes late will put everyone behind and we don't want you to be late for your special day!

____ The number in your party **MAY** increase if time allows. Additional charges may apply. Call your coordinator to request an increase as soon as possible.

____ Time changes for the ceremony **MAY NOT** be accommodated after signing of the contract due to scheduling conflicts. Please contact your coordinator to inquire. If time change cannot be accommodated, the full amount of the contract is due in full regardless if services are rendered or not.
